BUSINESS NAMES ACT [CAP 211]

Business Names Regulation Order No.113 of 2015

In exercise of the powers conferred on me by section 27 of the Business Names Act [CAP 211], I, the Honourable WILLIE JIMMY TAPANGARARUA, Minister of Finance and Economic Management, make the following Order.

To provide for forms and fees for the purposes of registration of business names.

1 Interpretation

In this Regulation, unless the contrary intention appears:

Act means the Business Names Act [CAP 211];

Registrar means the Registrar of business names for the purposes of the Business Names Act [CAP 211];2 General requirement for documents

- (1) All documents required by the Act or the Registrar must be easily readable by the Registrar.
- (2) If a document is required to be signed:
 - (a) the signature must be an original signature; and
 - (b) the name of the signatory must be clearly typed, printed, stamped, or written adjacent to the original signature.
- (3) The registrar may accept documents in electronic form, and may determine the requirements, including any requirements in respect of signature that applies in respect of documents provided in electronic form.
- (4) Subclauses (1) and (2) apply to documents provided in electronic form subject to any modifications determined by the registrar.
- 3 Forms
- (1) The prescribed forms are as set out in Schedule 1.
- (2) Any person applying for registration of a business name must:

- (a) provide a valid email address and mobile phone number for the purposes of receiving notifications by the office of the registrar; and
- (b) notify the registrar of any changes to the email address or mobile phone number.
- (3) A person applying for registration of a business name who is not a citizen of Vanuatu must provide a copy of his or her passport when applying to register a business name or when requested by the registrar.

4 Fees

- (1) The prescribed fees are set out in Schedule 2.
- (2) All prescribed fees under this Regulation are to be paid to the Registrar.

5 Penalty

- (1) The penalties that are to be imposed for the purpose of subsection 18(2) of the Act are set out in items 2(a) and 6 of Schedule 2.
- (2) The penalties under subclause (1), are to be paid in addition to any standard fee required to be paid under the Act or this Regulation.
- (2) Despite subclause 5(1), the Registrar may waive wholly or partly the fine under subclause (1) if:
 - (a) the Registrar is satisfied that the omission to deliver the document within the time limit was due to an oversight; or
 - (b) it is just and equitable to do so.

6 Commencement

This Order commences on 31 August 2015.
