

# **GENERAL NOTICE TO INTERNATIONAL COMPANIES**

Due to the commencing of the <u>International Companies (AMENDMENT) Act. No. 4 of 2016</u> on the 7<sup>th</sup> July 2016, the Vanuatu Financial Services Commission (VFSC) would like to inform its valuable international company clients and agents of the latest important requirements provided under this Act.

#### **Important Amendments**

## **Section 1(1) Definition of Registered Agent**

""Registered agent" means a person who is at any particular time performing the functions of the registered agent of a company under this Act and who is <u>licensed under the Company and Trust Services</u>

Providers Act No. 8 of 2010."

## Section 125 - Register of Beneficial owners

- (1) The Commission is to keep a Register of beneficial owners of companies.
- (2) A person intending to incorporate a company under this Act MUST disclose to the Commission details of the beneficial owners of the company as the Commission may require.
- (3) The Commission must not incorporate a company under section 5 unless the person applying for incorporation complies with subsection (2).
- (4) A company incorporated *before* the commencement of this Act MUST disclose to the Commission details of beneficial owners of the company within 3 months of the commencement of this Act.
- (5) A company must notify the Commission of any change in its beneficial owners within 3 months of the change in ownership and must provide such information of the new beneficial owners as the Commission may require.
- (6) A company that fails to comply with subsections (4) and (5) will be struck off the Register of Companies.
- (7) An agent who:
  - (a) having been informed by the company of the changes in beneficial ownership; and
  - (b) fails to file such changes with the Commission,
  - (c) commits an offence punishable on conviction by a fine not exceeding US\$100,000.

# Section 125A (3) (4) and (5) Confidentiality of company records.

#### **Application**

- All existing registered agents will be in compliance under the <u>Company and Trust Services</u>
   <u>Providers Act No. 8 of 2010 (CTSP)</u> i.e. agents that are not yet licensed will be informed by the VFSC to apply and acquire a licence under the CTSP Act within a period of 3 months of the Commencement of this Act.
- New registered agents are advised to apply for the specific licence under the CTSP Act before becoming an agent and eligible to incorporate an international company under this Act.
- All new incorporation application must include a separate document named 'Company Records' which details all required information stated under Section 125A (1) (2) of this Act.
- All company records of beneficial owners are highly confidential and are keep in a secured Registry of its own with the VFSC.
- Disclosure of beneficial owner records can ONLY be done according to Sections 125A (6) (7) (8) (9) and 125B
- No additional fees for registration of beneficial ownership apply.
