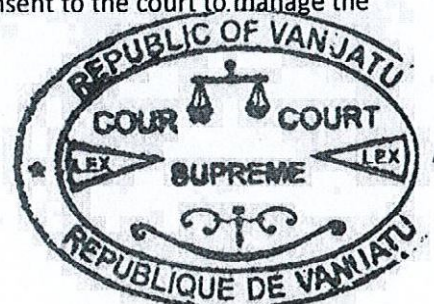

**IT IS HEREBY ORDERED:**


1. That Application for extension of time is dismissed on the basis that the applicant has no standing.

3. That proposed liquidation MacGill to submit his written consent to the court to manage the liquidation.



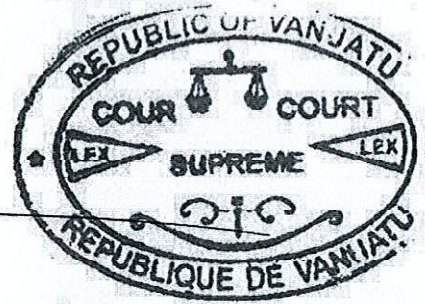


4. That counsel to submit a memo after consultation with her principal as to whether the court needs to have continued oversight of the liquidation process.




